SaxoCell e.V. – Membership Fee Regulations

According to §7 of the Statutes of SaxoCell e.V. (the “Association”)

§1 Annual Membership Fee

1. The amount of the annual membership fees for full members is graduated according to their type and the turnover or size of the previous year (as of June 30) as follows:

a) Companies

- **Start-ups:**

- In the first year after foundation: **€50**
- In the second and third year after foundation: **€200**

- **Established companies:**

- Up to 10 employees: **€600**
- Up to 50 employees: **€1,000**
- Up to 250 employees: **€2,000**
- More than 250 employees: **€3,000**

b) Cities

- Under 100,000 inhabitants: **€8,000**
- Over 100,000 inhabitants: **€12,500**

c) Universities: **€2,500**

d) Clinics (including university hospitals): **€2,500**

e) Institutes of research organizations or professorships at universities (per institute/professorship), provided that the research organization or university itself is not already a member: **€500**

f) Other associations or societies: **€1,000**

g) Individuals: **€100**

h) Students: **€20**

i) Members that are not natural persons and whose parent legal entity, partnership, or other institution (sponsoring

body) is already a member (*except institutes of research organizations and professorships at universities*):

€1,000

2. The relevant figures are always those of the previous year regarding the number of employees or inhabitants. Upon request by the Executive Board, members must provide appropriate proof of these numbers.
3. **Associated members** do not pay a membership fee.
4. The **membership fee for supporting members** is **€3,000**.
5. The amount of the membership fee is determined by the Executive Board upon admission and communicated to the member.
6. Membership fees are **annual fees**, payable in full on **January 5 of each calendar year**.
7. If a member joins during the current year, a **pro rata fee** must be paid until the end of the month following admission.

§2 Entry into Force

These membership fee regulations take effect immediately.

Membership fees for the current year 2023 shall be paid in accordance with §1(7) of these regulations.
